Program Features	Accelerated: fall and spring classes meet in 8-week sessions; summer meets in 6-week sessions Asynchronous: self-learning, self-paced, self-directed; no real-time instruction Cohort: Limited number of students admitted each fall and spring all following a custom schedule	
Tuition	\$550 per unit; financial aid (including grants, loans, and scholarships) is available Flexible payment plans	
LOWER-DIVISION REQUIREMENTS		
Lower-division requirements:	Include courses needed to meet graduation requirements at <i>Channel Islands</i> but may not have been needed at your community college. Examples of missing courses include:  • <u>Language requirement</u> (demonstrate proficiency in a language other than English)  • <u>American Institutions</u> (demonstrate competencies in U.S. History, U.S. Constitution, & California State and local government for a total of 6 units)  • Ethnic Studies	
	Missing lower-division courses may be completed at a community college (CC). However, if you have already transferred the maximum allowable 70 CC units, any additional units earned from these courses will not count toward the 120 units required for graduation at CSUCI. This means you will still satisfy the missing course requirement, but no additional unit credit will be awarded toward your degree.	
How to satisfy the language requirement?	Take a course (C- or better grade required) or take a test to prove proficiency in a language other than English.	
How to satisfy the multicultural requirement?	Our UDGE C course (MUS 330) also satisfies the multicultural requirement.

UPPER-DIVISION REQUIREMENTS		
Upper-division requirements:	Include 11 upper-division business major/core courses  • Curriculum: <a href="https://ext.csuci.edu/programs/undergraduate/bs-business-online/curriculum.htm">https://ext.csuci.edu/programs/undergraduate/bs-business-online/curriculum.htm</a> • Students must obtain a grade of "C-" or better in each course.	
	Include 3 upper-division general education ( <u>UDGE</u> ) courses  • Courses are identified and selected by the online program <b>NOT</b> the student  • Grades of "C-" or better are required	
	<ul> <li>Include up to 5 upper-division business elective courses</li> <li>Numbers of courses needed depends on total number of units transferred in</li> <li>Grades of "D-" or better better required</li> <li>Course are identified and selected by the online program NOT the student</li> </ul>	

#### HELPFUL INFORMATION

- Advance placement (AP) and/or College-Level Examination Program® (CLEP) exams can count for college credit. Be sure to submit your official score reports!
- A grade point average of at least 2.0 overall is required to earn the degree.

- A minimum of 120 units is required to earn the degree.
  - o 70 units maximum can be transferred in from a community college or another two-year college
  - o Remaining units to complete in the Business Online Completion Program at CSUCI:
    - 31 units of business core courses

Who to contact?

- 9 units of upper-division general education (UDGE) courses
- ~15 units of business elective courses
- CSUCI residency requirements; this is important if planning to transfer from another 4-year, accredited institution
  - o 30 units must be taken in residence at CSUCI
    - 24 units must be upper-division coursework
    - 12 units must be in the major
